# Sponsor a Berth Today

Yes, I would like to donate £1,000\* to help fund a berth for a year.

\* Only £625 to 50% tax payers.  
Only £750 to 40% tax payers.

If you are a higher rate tax payer, you can claim the difference between the higher and basic tax rates on either income or capital gains tax. If you pay 50% tax, you can claim 30% (50%-20%) on the value of your donation including gift aid ie £375 (£1,250 x 30%) reducing the cost of your £1,000 donation to £625. The equivalent cost for a 40% tax payer is £750.

\* Only £740 to companies.

A company can claim tax relief on a donation when calculating its profits for corporation tax. R240's, gift aid declarations and/or CT61's are not required. At the full corporation tax rate of 26%, this means that a donation of £1,000 only costs a company £740 (from April 2012, £750 when the rate drops to 25%).

## PAYMENT METHODS

It will help us to reduce the cost of admin if you are able to give your donation as a one-off payment but you can also pay in 10 monthly instalments of £100 if you prefer:

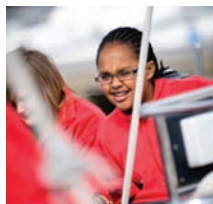
